Master Board of Directors Meeting Minutes May 17, 2012 – 6:30 p.m. Kinderton Village Club House

### A. <u>Yard-Nique</u>

Brian Phillips outlined Kinderton's turf program and contract coverage.

### A. <u>Security Cameras</u>

The Board received several bids for security cameras. The bids range in price from \$16,850 to \$25,896. The Board learned that the security cameras themselves may be stolen because there is no way to secure them. In addition, these cameras may or may not be able to capture license plate numbers.

The Board is very concerned with the safety of our community and will look at other options presented by the Neighborhood Watch Committee. However, due to the danger of theft, high cost, and questionable reliability, the Board will table this issue until next year.

## B. Main Entrance Sign

After annexation, signs must be approved by the Town of Bermuda Run. The Board will table this issue until the July meeting.

### C. <u>Club House Basketball Goal</u>

Pat Russell was able to locate and install a shatterproof backboard for \$197.

### D. Field Maintenance (North Forke and Rosewalk)

Premiere Lawn Service has completed the field maintenance at a cost of \$5,850. This price included: removing trash and rocks, bush hogging, leveling the field, and seeding bare areas.

#### E. Kiosk Brochure Holders

Shannon Walton (CAS) has ordered 30 brochure holders for the mail kiosks. The old, faded holders will be replaced. Brochure holders will be added to the sides of the mail kiosk that have mail slots.
