#### **Committee Reports:**

#### 1. **Pool**:

a. Ann to contact Pool professionals to ensure they are familiar with resetting the utility closet power supply when there is a surge during a storm

#### 2. ARC:

- a. Ann to send notices to several owners for failure to comply to notices
  - i. Ann urges residents to contact her in response to violations, and let her know there is a plan to resolve the violation.
  - ii. A 5 day letter will be sent, giving 10 days to comply, and then a \$1/day fine will be imposed and pool pass suspended until the violation is resolved.

- 3. Bus Stop: Signs have been ordered for restricting parking on town park at park view and will be placed once received.
- 4. Extension of Lakeside Crossing: Lee Rollins is waiting documentation on land plat before proceeding.
- 5. South Entrance: The board currently has one bid for an 8 ft long and 5 ft tall entrance sign at a cost of \$6,200. Additional costs for landscaping and irrigation will need to be considered. The board will get additional quotes. Reserve study needs to be evaluated to determine when proceeding with the entrance sign is most appropriate.
- 6. 4<sup>th</sup> of July Parade: Pat has enlisted the help of another resident to take over the 4<sup>th</sup> of July Parade duties.
- 7. The board is looking for a resident to take over the managing of the clubhouse. Pat Russell has been in charge of the clubhouse responsibilities on a volunteer basis, but will be scaling back his role.
- 8. Signs "Restrictive Covenant" Community at entrance: New signs will be ordered to replace the faded signs.

#### **New Business:**

- Playground Committee: Jean Carter and Lauren Hudson have expressed interest in forming a committee to investigate the costs of renovating the playground.
- 2. Ann presented the budget for review to prepare for 2016 budget.
