## KV Board Of Directors Speaks Out

The KV Board addresses a serious health and aesthetic issue in our community

No resident wants to see or deal with animal waste in their yard or in the common areas. We can't do much about the deer that wander through our neighborhood, but dog owners can, and should, assume responsibility for the waste created by their pets.

Kinderton Village is a dog friendly community and a large percentage of our residents own dogs. Most dog owners properly care for and pick up after their dogs, and this is greatly appreciated by everyone. However, a small percentage of dog owners choose to ignore this responsibility, and therein lies the problem. Cleaning up your dog's waste is not only the right thing to do for the sake of other residents, but it's required by the Kinderton Village Covenants\*. The Covenants require residents to maintain their dog(s) on a leash, with no excessive barking, and also require the immediate pick up and proper disposal of waste.

In recent weeks reports have been received about excessive amounts of dog feces in many common areas and in private yards. The sight and odor of dog feces is extremely offensive, and its presence in common areas infringes

upon the rights of all residents, guests, and their children to enjoy a clean, safe environment. Teens and adults alike have concerns about playing Frisbee or touch football in our large common areas. Community events like the annual Easter Egg Hunt or a Music Festival cause concern due to the possibility of stepping in or placing a blanket on dog poop!

Dog fecal waste is more than just a nuisance; it can pose a serious health hazard. A number of common parasites, including round worms, are transmitted via dog feces, and when infected dog droppings are left on the ground, the eggs of the roundworms and other parasites can linger in the soil for years. Anyone who comes in contact with this soil also comes in contact with the infected eggs. To fully understand the potential health hazards, we encourage you to do your own internet search. (See the **Helpful Links** section of the newsletter).

The Board of Directors is seeking the full cooperation of all property owners and their tenants in a joint concentrated effort to completely eliminate dog feces from the grounds of

Kinderton Village. If you observe anyone violating the Covenants by allowing their dog out in the common areas without a leash or by not cleaning up their dog waste, you are requested to respectfully inform that individual of their violation and, if feasible, give them a copy of this publication. If you are not comfortable approaching the individual, please gather as much information as possible of the violation and submit a report to our management You will find the company, CAS. appropriate contact information on the Kinderton Village Website at www.kindertonvillage.org.

We look forward to the opportunities and prospects for improvements to the quality of life in the Kinderton Village community. This is a great community and working together with common beneficial goals we will preserve the freshness of the community.
