I hear talk about the possible annexation of Kinderton by the Bermuda Run Town Board and wonder if this is a probability/possibility or not. This same talk says if annexed that Kinderton residents could expect a tax bill of \$. 15 per \$100 per year and that the present Homeowners Dues would continue at their present rate. Is this public knowledge and I am just in the dark or will this be openly discussed in a future KOA Board meeting? Will the residents be permitted to have in-put into this talk or not? Will there be a vote on this? What are the benefits of this annexation? What are the drawbacks? Anyone care to comment on this - those who might be in the know on this?

Response from Dick Heriot, Secretary, Single Family Board Of Directors and Annexation Study Leader

Yes, there is a possibility of annexation by Bermuda Run.
