Master Board of Directors Meeting Minutes February 21, 2013 – 6:30 p.m. Kinderton Village Club House

I. The meeting was called to order by Helen Kelly at 6:35 p.m.

II. Minutes of the previous Board meeting were approved.

### III. <u>Unfinished Business</u>

#### A. Main Entrance Sign

The Board voted unanimously to hire Pat & J Masonry for the brickwork (\$3,940). Aluminum sign will be ordered from Davis Sign (\$4,096).

## B. Kiosk Parcel Box Maintenance

Eagle Mailbox is working to repair parcel boxes.

## C. <u>Neighborhood Watch Signs</u>

#### D. <u>Violations Update</u>

Board discussed current issues.

#### E. Lake Silt Ponds/Reservoirs

The Board voted unanimously to hire Dragonfly Pond Works. Work includes the following:

- Treatment of willow re-growth and cattails
- Cleaning and grading of large inlet area
- Removal of 10' sections of berms at two silt ponds
- Lake shoreline enhancement
- Quarterly maintenance

Cost is approximately \$20,000.

#### F. 2013 Canada Goose Options

## G. 2013 Landscaper

Board unanimously approved Blakely Landscaping. Contract begins April 1, 2013, for an annual cost of \$29,000.

#### H. <u>Hill Erosion Behind Lake Point Drive</u>

Yard-Nique's monthly payment will be withheld until 1) work behind Lake Point Drive is completed and 2) weed pre-emergent is applied.

## I. <u>Site Improvements</u>

Contractor has determined that the repairs to the Greenway gazebos are more extensive than originally thought. Repair is estimated at \$4,500 to \$6,000. Board voted unanimously to proceed.

Pat Russell will inspect the gazebo park benches to determine if they can be refinished. Pat will purchase a chair cart for the Club Room.

### J. Open Meeting Follow-Up

Trent Adams, the Declarant, declined to transition the day-to-day management of the ARC to the Master Board. The Board will again discuss this issue with the Declarant.

### K. Club House Parking Lot Repair

Board unanimously approved CACTX to repair the Club House parking lot. Approximate cost is \$4,968.

## L. <u>Landscaping for Hill Behind North Forke and Rosewalk</u>

Homeowners whose lot back up to the North Forke/Rosewalk hill will be invited to a meeting on Thursday, March 7, to discuss beautification of the hill.

#### M. Fine Violation System
